- 2. There is **no water available** at Miner Park except in the restroom facilities.
- 3. Pavilions 1-4 and the Bandstand at Miner Park have electricity. If a breaker trips during your event **the Village will not send out any park staff** to reset the breaker. Breakers will be reset on the next working day.
- 4. Please <u>place all trash in the trash cans</u> provided. Village staff will collect and dump the trash cans during normal working hours.
- 5. If you need to move tables from one pavilion to another please make sure you <u>return the</u> tables to the pavilion you have taken them from after your event.
- 6. Please keep a copy of your reservation form with you on the day of your event.
